Input from DH - survey is to establish statistically valid responses as to needs and preferences of County citizens. County Commissioners will review the survey responses and pursue identified priorities in greater detail.

- ❖ Q11, correct text to reflect “Question 10”
- ❖ Q12, no question or revision, good supportive discussion
- ❖ Q13, addition of “10. Library Services”
- ❖ Q14 - Q17, no question or revision, good supportive discussion
- ❖ Q18, suggest addition of “wind” to “...residential/private business **wind**/solar...”
- ❖ Q19, suggest addition of “Recreation” to listing
- ❖ Q20 - Q23, no question or revision, good supportive discussion
- ❖ Q24, suggest striking this Comment section - pending ETC expertise otherwise
