County Powers & Responsibilities includes:

Zoning

Police Power (protecting public interests / public safety)

Police Powers cannot be used to regulate zoning within a city's jurisdiction.

Regulation Discussion

Zoning determines where and how certain uses are permitted.

Police Power regulate:

- Administrative and safety matters
- Impacts or benefits specific project types
- Basic facility requirements
- Minimum standards
- Public hearings
- Conditional-use permitting requirements

Police Powers also address:

- Decommissioning
- Storm water drainage
- Public safety and welfare issues

Draft Resolution Provided

Council Hughes shared a draft Conditional Use Resolution, allowing for project-specific requirements.

Industry-Specific Discussion

AI Centers / Crypto Mining / etc.:

Certain uses, such as water use, are already regulated by established entities (e.g., the State of Kansas Water Board or similar authority).

Resolutions Provided by Patrick H.

1. Proposed Zoning Amendment
2. Proposed Police Powers Amendment

Discussion on both resolutions was held.

Both resolutions are restricted only to solar.
